Dar es Salaam, Taasisi ya Utafiti wa Kupunguza Umaskini (Repoa), imetoa tahadhari kwa Serikali na Watanzania kupunguza matumaini kwenye manufaa ya gesi asilia huku ikipendekeza kuanzishwa kwa sekta endelevu itakayokuwa mbadala wa rasilimali hiyo.

Mkurugenzi wa Mipango na Utafiti wa Repoa, Dk Abel Kinyondo alisema matumaini yaliyopo ni makubwa ikiinganiwa na uhalisia kwani makosa yaliyofanyika ni kutoa nafasi kubwa kwa Watanzania kushiriki katika rasilimali hiyo wakati hawana uwezo wa kutosheleza mahitaji na ubora unaohitajika.

Kabla ya kanuni kukamilika, Sera ya Ushirikishaji na Uwezeshaji Wazawa Tanzania (LCP) ya mwaka 2014, Sera ya Gesi Asilia ya 2013 na Sheria ya Usimamizi wa Mapato ya Gesi Asilia ya 2015, Serikali iliweka mkakati wa kuhakikisha wazalishaji na kampuni za ndani zinawafika kwa asilimia 25 wakati wa uzalishaji.

masuala ya uchumi na mikataba ya gesi na mafuta kwa wanahabari, Dk Kinyondo alisema kinachoweza kusaidia ni Serikali kuongeza kodi na kupunguza ushiriki wa LCP kwa Watanzania ili kuelewa wajanja wachache watakaojinuitaisha wakati wa uzalishaji.

Mkurugenzi Mtendaji wa Repoa, Dk Donald Mmari alisema endapo Taifa litakuwa na filira ya uchumi kujengwa kwa gesi pekee ni kosa kubwa kwa kuwa baadhi ya nchi zikiwamo Angola na Venezuela zinajuta kwa sasa licha ya kupata utajiri wa rasilimali hiyo.

"Sasa tunatumie sekta ya gesi kumarisha kilimo na ku-promote viwanda bila mtazamo mpana ili tustipate shida ya utegemezi. Tunaweza kujikuta kwenye matatizo yaliyojitokeza Venezuela na Angola," alisema.

Mkurugenzi Mtendaji wa Taasisi ya Sekta Binafsi Tanzania (TPSF), Dk Godfrey Simbeye alikiri kuwapo kwa hofu ya wajanja wachache kumafika na wazalishaji wadogo kutomfika.

"Ni kwevi wajanja wachache wenye uwezo wanaweza ku-take advantages (kutumia mwanya huo), lakini changamoto hiyo ni vyema ikajibiwa kwenye kanuni zitakazoandaliwa na Serikali kwa ajili ya utekelezaji wa sheria hiyo, siji kwa sasa imefika wapi maandalizi yake," alisema.

Mipango huo ulitangazwa juzi na Nalibu Waziri wa Kilimo, Mifugo na Uvuvi, William ole Nasha katika ziara yake ya kuanzisha na kutafuta uhumu changamoto zinazozika-bili sekta wanazosimamia.

Ole Nasha alitwaga wataalamu wa kilimo waliyavuti hapa kuongeza kasi ya kuwekwa imisha wakulima mbinu za kilimo bora cha chai. "Kwa upande wa wizara tutahakikisha miche ya ruzuku inawafika wakulima kwa wakati ili styo tu waongeze uzalishaji, bali

kukaza kipato chao," alisema.

Kiwanda cha Chai Tarime kina uwezo wa kuzalisha tani nane kwa siku, lakini kwa sasa kinazalisha tani moja.

Akizungumza mazaao ya chakula, Luoga alisema sehemu hiyo huzalisha zaidi ya tani 140 kila mwaka ikiwa ni ziada ya tani 89 za mahitaji ambayo ni tani 51 kwa mwaka.

"Lakini tunakabiliwa na changamoto ya wanananchi kutokuwa na utamaduni wa kuhifadhi chakula cha ziada kwa mahitaji ya familia baada ya mavuno na baadhi hutumia nafaka kutengenezea pombe za kienyeji huku wengine wakizuza," alisema.
