Parliamentary Centre meets Parliament of Tanzania



REPOA had a chance to facilitate a validation meeting between the Parliamentary Centre and the Parliament of Tanzania and Civil Society Organisation (CSOs) on November 28, 2012 at REPOA conference Hall A as phase two of the Africa Parliamentary Index.

The Parliamentary Centre, as part of its CIDA – funded Africa parliamentary Strengthening Program (APSP) for Budget Oversight successfully conducted the Self – Assessment of the Parliament of Tanzania as part of the second phase of the Africa parliamentary Index (API).

The API is a set of indicators that show the level of engagement of selected African Parliaments in the budget process in their respective countries. It also measures the performance of Parliaments in selected African countries on budget oversight. The API requires a self assessment by Members of Parliament (MPs) and a validation of the outcome with MPs and Civil Society Organisation (CSOs).

Ethics, Payments and Maternal Survival



REPOA is undertaking research funded by the Well come Trust to investigate -How do the payments that women make for maternal health care influence their experience during pregnancy and birth?. The project is led by Dr Paula Tibandebage of REPOA, with research collaborators from the Open University, UK, the Economic and Social Research Foundation (ESRF), Dar es Salaam, and the National Institute for Medical Research (NIMR), Dar es Salaam.

1. Strategize on ways in which researchers and news editors to influence policy decisions using evidence based research Follow-up on research findings to establish credibility and package them for their specific audience
2. Link research findings with current policy issues;
3. Build effective relationships with research institutions

Call for Proposals Capacity Development Research Grants

REPOA has already announced the 1st call for proposals for the year 2013.

REPOA research grants aim to develop a vibrant community of beginning and intermediate researchers capable of undertaking research that is credible and relevant to development challenges, with special attention to policy development issues. Support is provided to short term studies (up to one year) in areas that are relevant to REPOA's overall research agenda. These studies aim to provide information that is relevant for the policy and practice of development that stakeholders can find useful in socioeconomic transformation for growth and poverty reduction initiatives, and offer beginning and intermediate researchers a platform to jump start and/or consolidate their research careers.
