### Remarks from REPOA's Core Partners

Mette Nørgaard Dissing-Spandet is the Danish Ambassador to Tanzania. She is credited with her work in support of multilateralism, human rights, peace and security. She joined the Danish Ministry of Foreign affairs in 1998. Prior to her appointment as Danish Ambassador to Tanzania in 2019, Ambassador Mette served in different positions including the International Law Department; the MENA Department; and the Africa Department. She also served as the Legal Advisor to the Security Council Team of Danish UN Mission in New York; Senior Adviser to the Danish Minister for Climate Change and Energy; Senior Adviser and Team Leader responsible for Afghanistan in the Stabilization Department. Further, as Senior Advisor in the EU Law Department she headed The Danish EU Presidency trilogue negotiations on access to information. From 2012 to 2016, Ambassador Mette served as Deputy Head and Head of Department, Human Rights Department. From 2016 to 2019 she was Head of Department - Public International Law and Human Rights. A lawyer by profession, Ambassador Mette earned her Masters of Law at Copenhagen University. Her Majesty the Queen Margrethe II, the Queen of the Kingdom of Denmark, has awarded Ambassador Mette with the Knight of the Order of Dannebrog.

### Remarks from the European Union on regional efforts to sustain competitive trade and resilience to climate change

Ambassador Manfredo started his career at the EU in 1993. He has always been working in the external relations of the EU with the countries of Eastern Europe and Central Asia, later with the Maghreb countries, in addition to Latin America and the Caribbean. He has led the Delegation of the EU in Tanzania since 2019 and is responsible for the management of all other activities of the Delegation. As representative of the European External Action Service acting under the authority of the High Representative and Vice President (HRVP), the EU Ambassador carries out at the level of the partner country, the EU foreign policy as the HRVP determines at central level. This task is implemented according to the mandate of the Council of the European Union, which is the institution gathering the Ministers of all EU Member States. Just as the HRVP chairs the meetings of the Foreign Affairs Council, so the EU Ambassador chairs the meetings of the EU Member States Ambassadors in Tanzania.

**Jean Paul Adam**

Director of Technology, Climate Change and Natural Resources Management Division, UNECA

Jean-Paul Adam is the Director for Technology, Climate Change and Natural Resources Management in the United Nations Economic Commission for Africa (UNECA). Prior to taking on this role, he served in the Government of the Republic of Seychelles in several Cabinet positions. He was Minister of Health from 2016 to 2019. He served as Minister of Finance, Trade and the Blue Economy from 2015 to 2016 where he negotiated a debt for climate change adaptation swap and launched the process for Seychelles to become the first issuer of a Blue Bond. Between 2010 and 2014, he was Seychelles' Minister of Foreign Affairs, where he advocated for countries to embrace the concept of the Blue Economy, to improve sustainability for island and coastal countries. Before entering the Cabinet, between 2005 and 2009, he occupied several senior roles in the Office of the President of the Republic of Seychelles including Director General for presidential affairs, Principal Secretary for the Office of the President and Secretary of state in the presidency. He started his career as a career diplomat in the Ministry of Foreign Affairs between 2001 and 2004. He is a holder of a Masters in International Political Economy from the University of Manchester (UK) and a BA in English Literature and French from the University of Sheffield (UK).

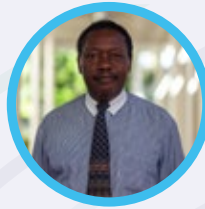

Peter has a Ph.D. in International Economics from Groningen University and a MA in theoretical economics from Erasmus University, where he was a Professor of Economic Policy in the Research Centre for Economic Policy (1998–2004). Peter has been strongly involved in policy making and banking. He served several high-ranking functions in economic diplomacy including the EU's Monetary Committee (1997-1999). Previous positions include Departmental Director of the Monetary and Economic Policy department of De Nederlandsche Bank NV (Dutch Central Bank) (1997-1999) and Director of UBS Group Economic Research, Zurich, Switzerland (1999-2001).

**Dr. Idil Ires**

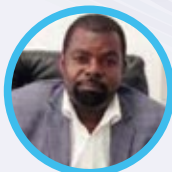

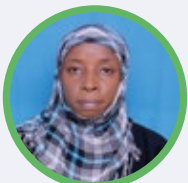

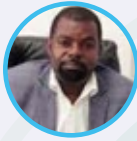
